A. Superintendent's Update

1. Mr. Ryan explained how the 2020-2021 school year calendar may be adjusted depending on how school is reopened. Mr. Ryan and the Board discussed the effect of remote instruction on the school year calendar. The Board of Education will approve adjustments to the calendar at the August meeting.

1. Mr. Ryan brought forth a resolution authorizing the Superintendent of Schools to comply with governmental regulations and guidance for the reopening of schools. The resolution was adopted by the Board of Education unanimously with -7- votes in favor and -0- votes opposed.


