 2018-2019 Budget Vote, Transportation Proposition,
 Security Proposition and Board of Education Member Election

A vote was held by the Fabius-Pompey Central School District on May 15, 2018, from 7:00 a.m. to 9:00 p.m. at the Fabius-Pompey Middle School-High School in Fabius, New York and at the Pompey Community Church in Pompey, New York on the following:

Proposition I: SHALL THE FOLLOWING RESOLUTION BE ADOPTED?

RESOLVED, that the Board of Education of the Fabius-Pompey Central School District, County of Onondaga, State of New York, be and hereby is authorized to expend during the fiscal year 2018-2019 the sum of \$18,513,553, as set forth in its statement of estimated expenses and to levy the necessary taxes thereof.

Proposition II: SHALL THE FOLLOWING RESOLUTION BE ADOPTED?

Shall the Board of Education be authorized to purchase three (3) 60-passenger school buses, including, for each, related furnishings and equipment incidental thereto at a total estimated cost not to exceed \$330,000, expend therefore a total sum not to exceed \$330,000 which is estimated to be the total maximum cost thereof, and pay for such buses by the levy of a tax which is hereby voted and approved in the amount of \$330,000 which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$330,000, and a tax is hereby voted to pay the interest on said obligations when due.

Proposition III: SHALL THE FOLLOWING RESOLUTION BE ADOPTED?

Shall the Board of Education make safety and security enhancements in all District facilities, including related site improvements, original furnishings, fixtures and equipment, architectural fees, and all other costs incidental to such work at a total estimated cost not to exceed \$1,000,000 and obtain the necessary funds by using any available state aid and the levy of a tax upon the taxable property of the School District to be collected in annual installments in the years and in the amounts as the Board of Education shall determine and in anticipation of such tax bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$1,000,000, and a tax is hereby voted to pay the interest on said obligations when due.
