### From the Superintendent

As we prepare to begin the 2025-26 school year, I am excited to share a comprehensive update on the initiatives, improvements, and opportunities that will positively impact our students, families, and the entire Fabius-Pompey community. This year marks an important period of growth and transformation for our District, with a focus on communication, modernized facilities, academic excellence, and student safety.

With your continued support, we are creating a stronger foundation for student learning and engagement, ensuring that every Falcon has the tools and environment to soar.

Our District newsletter has been revamped for the 2025-26 school year. Instead of monthly issues, we will produce five full-color newsletters distributed in September, December, March, May (Budget Edition), and June. Each edition will feature major District updates, student achievements, upcoming events, and progress on our initiatives.

To further improve communication, we are expanding our use of ParentSquare and our District website for timely updates.

Families can also expect a weekly ParentSquare message from me, recapping the prior week and previewing the next. This communication plan ensures that all families stay informed and engaged, from UPK through 12th grade.

The launch of our \$19.1 million capital improvement project, Project 2026, is one of the most exciting developments this year. This multi-phase project will modernize facilities, improve student spaces, and enhance athletic and community areas.

At the elementary school, the first stage of work involves milling the parking lot in preparation for future upgrades. Bus garage parking area improvements are planned for summer 2026. To ensure safety during construction, fenced staging areas and contractor trailers are now in place across the District.

At the high school, abatement work will have taken place before construction of a state-of-the-art technology and agriculture wing begins in the fall, which will include a modern greenhouse and updated STEAM classrooms. These new spaces will offer handson experiences in science, technology, and agriculture, preparing students for college and career success.

Our athletic facilities will also see major upgrades. After the fall sports season, we will install new soccer bleachers, improved walkways, and field lighting on the varsity field. Both JV and varsity baseball fields will receive fencing and dugout improvements. After the winter sports season, we will renovate the high school gymnasium, including a new floor and bleachers, creating a vibrant, school-spirited space for athletics, physical education, and community events.

Additionally, our high school auditorium will receive upgrades to its lighting and sound systems, including a new sound board and modern stage lighting. These enhancements will elevate performances, concerts, and community events, giving our students and audiences a professional-quality experience.

These improvements are an investment in our students' futures, and we will provide regular updates as Project 2026 progresses.

The 2025-26 school year also marks the official launch of our District Strategic Plan, developed collaboratively with students, staff, and community stakeholders. This plan serves as a roadmap for growth and focuses on three primary goals:

#### **Enhancing Academic and Enrichment Opportunities**

We are expanding STEAM programs, Career and Technical Education (CTE) offerings, and college-level courses to provide more pathways to student success. At the elementary level, enrichment clusters and extracurricular opportunities will be broadened, giving students a more well-rounded educational experience.

#### **Vertical Curriculum Alignment**

We are aligning content and skills from UPK through Grade 12, ensuring students experience a cohesive academic journey. Vertical alignment teams are addressing gaps and redundancies, strengthening instructional continuity.

#### **Improving Communication**

We are launching new District communication guidelines, streamlining ParentSquare and our website, and creating more opportunities for two-way engagement with families.

This strategic plan reflects our commitment to academic excellence, equity, and opportunity for every student. We are proud to welcome three new staff members to our Falcon

family, each bringing unique skills and passion to their roles:
Brenden Kirkpatrick – Elementary School Nurse. Brenden will
lead efforts to ensure the health and wellness of our youngest
learners. He will manage daily student medical needs, maintain
health records, and provide health education to families. Brenden
will also focus on preventative care, medication administration, and
emergency response, helping to maintain a safe and supportive
learning environment.

Ty Kovalewski – Middle/High School Technology Teacher. Ty will play a key role in expanding our STEAM and Career & Technical Education programs, teaching courses that develop 21st-century skills such as DDP, engineering, and technical drawing. He will also collaborate with our agriculture program to create hands-on technology projects, preparing students for careers in high-demand technical fields.

Ethan Wojcik – High School Band Teacher. Ethan will lead our high school band, inspiring students to achieve their highest musical potential. He will organize performances, mentor aspiring musicians, and strengthen the arts culture in our District, ensuring music remains a vibrant part of the Fabius-Pompey experience.

We are thrilled to have these talented educators join our team and look forward to the positive impact they will have on our students and programs.

Student safety is a top priority, and this year we are introducing two major safety initiatives:

#### **Stop-Arm Cameras on Buses**

All District buses are now equipped with stop-arm cameras to capture and deter traffic violations, keeping our students safer as they board and exit buses.

#### **Bell-to-Bell Cell Phone Policy**

Per the new New York State mandate, students must store all personal devices (phones, smartwatches, tablets) from the first bell to the last bell.

- MS/HS students will store devices in lockers.
- Elementary students will keep devices in backpacks in cubicles if they bring them.
- Emergency communications can be handled via Chromebooks or office phones.

Progressive consequences are in place for misuse, including warnings, device confiscation, and parent retrieval for repeated violations. This policy promotes distraction-free learning environments for all students.

To start the day with focus and structure, the Middle/High School will now have a homeroom period from 7:45 to 8 a.m. This time allows students to receive announcements, prepare for classes, and enjoy breakfast. Instruction begins promptly at 8 a.m., setting the tone for a successful school day.

As we begin the 2025-26 school year, I want to thank our families and community members for your partnership and support. With your help, we are fostering a learning environment that promotes growth, engagement, and success for every student.

Welcome Back to the 2025-26 School Year!



# **TRANSPORTATION NEWS**

**WELCOME BACK!** With the 2025-26 school year fast approaching, it's time to get students and parents ready! We're excited to welcome our new students and to see our returning ones. On September 2nd, the wheels on the buses will start rolling to bring our most precious cargo, your children, safely to school.

#### **Safety is Our First Priority**

We know the school bus is the safest mode of transportation for students. Frequent and thorough inspections ensure every bus is in top condition. New York State has some of the safest school bus drivers in the nation, thanks to mandatory training, testing, and driving reviews throughout the year.

In recent years, many parents have chosen to drive their children to and from school. If your child will not be using the bus, please let us know by contacting Diana Carpenter at 315-683-5278.

Parents and guardians play a critical role in keeping children safe. Please review bus rules with your child and explain the importance of following them. Even a single distraction can cause a driver to lose focus, which could result in a serious accident. Students should: Sit in their assigned seat, facing forward at all times; keep the aisle clear; and remain in assigned seat).

#### **Daycare Transportation Requests**

If your child will require daily bus transportation to or from daycare, please submit your request before the first day of school if possi-



ble. If daycare arrangements change during the year, allow up to two weeks for adjustments.

#### **Video & Audio Recording on Buses**

To support safe transportation, our buses are equipped with video and audio recording systems. These tools help identify disruptive behavior, allowing drivers to focus on the road.

#### **Working Together for Safety**

If you have concerns or if a transportation rule creates a challenge for your family, please contact us so we can discuss solutions. Proper bus behavior is essential for the safety of all passengers.

#### **Pick-Up Points**

The Transportation Supervisor may establish pick-up points within village limits where population density allows. If no pick-up point is assigned, door-to-door service is provided.

#### **Late Buses**

Late buses depart the high school at approximately 3:30 p.m. Routing is determined by the driver based on the passengers riding that day. Specific arrival times cannot be guaranteed. Five late buses cover the entire District.

If your child must be home or at another location at a specific time, please arrange for pick-up. Students may get off a late or activity bus and walk a reasonable distance only with written parental permission submitted in advance.

Phone calls during the bus ride are not an acceptable form of permission.

PLEASE TRY TO PICK ONE PICK-UP AND ONE DROP-OFF LOCATION TO ACCOMMODATE ALL STUDENTS WHO WANT TO RIDE.

#### **After-School Destination Changes**

If a student will be going somewhere after school other than their regular home address, a parent or guardian must make this change for all students, regardless of age.

- Middle and High School: A written note from a parent or guardian is required.
- Elementary School: Changes should be made using PickUp Patrol.
- Please note: Cell phones cannot be used to request a change in destination.

#### **Bus Safety Reminder**

Students should go directly home after getting off the bus. They may not retrieve mail, newspapers, or other items before crossing the road.

### PARENTS/GUARDIANS: Ways You Can Help Keep Students Safe

- Make your house number visible from both directions so bus drivers can locate your home easily.
- Have your child ready at least 10 minutes before the scheduled pickup time. Students should be waiting for the bus. Buses cannot wait for late arrivals. While buses are typically on time, occasional delays can happen, so please be patient. Buses do not return for missed pickups.
- Never allow a child to run after a missed bus. This is extremely dangerous.
- Do not leave young children unattended at the bus stop, and never pull up behind the bus to drop them off, the driver may
  not see you, putting your child at risk.
- For elementary school students, ensure a responsible adult is at home by 2:35 p.m. to receive your child. The bus may arrive earlier or later than usual. If no one is home, children will be returned to the elementary school office for pickup.
- Teach your child to wait at least 15 feet from the road in a spot where the driver can easily see them. If they drop something near or under the bus, they must tell the driver. If you can't see the driver, the driver can't see you.
- Use a small backpack or book bag for safety. Avoid items like drawstrings, scarves, chains, straps, or mitten strings that could get caught in the bus door.
- Only bring items that fit on a student's lap. Large projects or oversized items should be transported by car.
- Discourage cell phone use on the bus, including taking pictures.
- Remind your child to be respectful to others and listen to the driver at all times.
- Parents must use the parent pick up/drop off location to the rear of the elementary building. It was established to prevent interaction of children and vehicles.

  No exceptions, please.
- Never walk alongside or between buses.
- Buses line up at 2 p.m. and no traffic will be allowed to pass through the parking lot.
- Student drop off is on the west side of the high school. Please stay out of the bus circle. Line up is 2:20 p.m.

# **NEWS and NOTICES**

### From the Health Office

Health examinations are now required by New York State for all students entering the school District for the first time and when entering grades Pre-K, K, 1, 3, 5, 7, 9 and 11. The examination must be completed by a New York State licensed physician, physician assistant or nurse practitioner.

Parents of 6th, 7th and 12th Graders: New York State immunization requirements for students entering the 6th, 7th and 12th grade: All students entering the 6th grade in September 2021 are required to have one dose of Tdap vaccine (Tetanus toxoid, reduced; Diphtheria toxoid and acellular Pertussis vaccine). Also mandated for 6th grade students is two doses of the varicella vaccination or proof of having the disease as documented by your health care provider. All students entering 7th and 12th grades must be fully vaccinated against meningococcal disease. The requirement is one dose of meningococcal vaccine required before 7th grade. If your child had the first dose as a 6th grader, then another dose is not required until 12th grade. Two doses will be required before 12th grade. Most students entering 12th grade received their first dose when they were younger and are now due for their second dose or booster.

Please contact your health care provider regarding these immunizations and send in documentation to either school once done. If you have questions, please contact your School Nurse. We appreciate your cooperation with this mandate. Thank you.

### **Notification of Pesticide Use**

Initial Notification to Persons in Parental Relation and Staff Pursuant to Section 409-H of the State Education Law.

New York State Education Law Section 409-H, effective July 1, 2001, requires all public and non-public elementary and secondary schools to provide written notification to all persons in parental relation, faculty and staff regarding the potential use of pesticides periodically throughout the school year.

The Fabius-Pompey Central School District is required to maintain a list of persons in parental relation, faculty and staff who wish to receive 48-hour prior written notification of certain pesticide applications:

When a school remains unoccupied for a continuous 72 hours following an application; • anti-microbial products; • nonvolatile rodenticides in tamper resistant bait stations in areas inaccessible to children; • nonvolatile insecticidal baits in tamper resistant bait stations in areas inaccessible to children; • silica gels and other nonvolatile ready-to-use pastes, foams or gels in areas inaccessible to children; • boric acid and disodium octaborate tetrahydrate; • the application of EPA-designated biopesticides; • the application of EPA-designated exempt materials under 40CFR152.25; • the use of aerosol products with a directed spray in containers of 18 fluid ounces or less for venomous spiders, bees, wasps and hornets.

In the event of an emergency application necessary to protect against an imminent threat to human health, a good faith effort will be made to supply written notification to those on the 48-hour prior notification list.

If you would like to receive 48-hour prior notification of scheduled pesticide applications, please contact the District pesticide representative, Richard Clancy, Buildings, Grounds and Maintenance Supervisor, Fabius-Pompey Central School District, 1211 Mill Street, Fabius, NY 13063. Please be sure to include your name, address, phone number, email address and school building(s) of interest.

### **Asbestos and Fire Inspections**

Asbestos Inspection - In compliance with the U.S. Environmental Protection Agency (EPA) Asbestos Hazard Emergency Response Act (AHERA), all asbestos-containing building materials in our school buildings have been inspected. The triennial was completed in the spring of 2025.

The EPA requires us to perform a six-month visual inspection and a re-inspection of the asbestos materials every three years. A New York State Department of Labor (NYSDOL) certified asbestos inspector has performed this re-inspection and a certified NYSDOL asbestos management planner reviewed the results.

We will continue to manage all asbestos material in place as recommended by EPA guidelines and the NYSDOL certified asbestos management planner.
