All of their instructional and public spaces are equipped with a robust wireless network environment. Periodically the technology staff, the instructional staff, and the BOCES technology planning staff review the wireless capacity and student demand.

This application focuses on two groups of devices. The first are a replacement of student chromebooks. These devices are replacements for existing chromebooks purchased during the pandemic that have exceeded their useful life. These devices will not impact the facility's electrical, HVAC, or other infrastructure services.

The second group of devices are iPads for the lower grade levels. The carts for storing these devices require a 110 outlet for charging that already exist in the classrooms. These devices do not require any upgrades or expansion of the existing electrical or HVAC infrastructure.

The classroom devices in this proposal supports all students in the Fabius-Pompey district. The specific goal of the hardware is to allow the staff and students shift to a more "inclusive" or "participatory" learning environment.

All students including those with handicapping conditions will be assigned personal devices either on a one-to-one or a classroom

model. Students with visual challenges can enhance the screens to reinforce presentations. All students can use the devices for extended learning rather than be limited to an arbitrary 42 minutes of their day. All students can use the device to practice or complete assignments during study halls or time with learning coaches.

Fabius Pompey is a small, almost rural school district in Onondaga County. English Language Learners have had to struggle with limited access to someone who can translate from English to their native language or from native language to English. Using the Google translate capacity on the chromebooks can reduce or eliminate this challenge. Additionally, the student may be able to access materials in the native language to clarify instruction that they haven't been able to access before. Additionally, the students can prepare work in their native language, and then translate it to English to facilitate participation.

This plan by Fabius-Pompey doesn't directly impact parent communication. Fabius Pompey does employ a robust parent portal through their student management system. Parents have access to student attendance, student assignments, reports of their students' progress and even discipline concerns. This information is available in real time for the parents rather than waiting until the end of a six or ten week marking period. Additionally, the parents have access to the instructor's email account to facilitate ongoing communication between parents and instructor.

The Fabius-Pompey School District will offer targeted professional development focused exclusively on supporting student Chromebook or iPad integration. Initial training sessions will cover essential skills such as powering on the devices, navigating the operating system, connecting to Wi-Fi, and basic troubleshooting. Hands-on workshops will guide participants through setting up and customizing their devices, using essential software for daily tasks, and managing digital files and folders. Additionally, we will provide guidance on integrating these devices into their activities, including utilizing the productivity tools. Ongoing support through one-on-one coaching and regular help desk hours will ensure students build confidence and competence in using their new devices.
